## NOTE FOR THE ATTENTION OF TCG

### **Subject: PoUS start of Operations on 1<sup>st</sup> March 2024**

After 5 years of collaborative preparatory work, we are pleased to announce that the Proof of Union Status system (PoUS) Phase 1 will enter the ‘Operations’ phase on the 1<sup>st</sup> of March 2024, in accordance with the project plan discussed with the ECCG and TCG and with the date defined in the UCC Work Programme.

The main objective of the Proof of Union Status (PoUS) system Phase 1 is to replace the paper procedure of T2L/T2LF used to prove Union status of goods with electronic means. From 01.03.2024 all new T2L and T2LF proofs should be endorsed and registered electronically in the new POUS system. As transition, proofs issued before 01.03.2024 can still be presented on paper until the end of their validity.

The PoUS System consists of the following key components:

- PoUS Specific Trader Portal (PoUS STP) for economic operators (with integration of the access management through what is called “Uniform User Management & Digital Signature” (UUM&DS)),
- PoUS Back Office (PoUS BO) for customs officers (with integration of other systems).

The PoUS System is configured to support the architectural approach chosen by Member States as specified in the PoUS Business case which was put for review to ECCG and TCG, and approved by the ECCG Members on 03.12.2019. All Member States (MS) will use the central PoUS system, except Spain and Poland, which have developed and will use their own national PoUS system, interfaced with the central PoUS system.
